
# 40 DAYS FOR LIFE-THE POWER OF PRAYER

# EUTHANASIA-OUR PRAYERS ARE NEEDED

Here in Rhode Island, many of us may be unaware of the growing push for the legalization of physician assisted suicide in several other states. In Massachusetts, euthanasia advocates are working towards a ballot question that will have voters decide on its legalization in November. In New York, Vermont, Hawaii, and Montana, state legislatures are debating bills to decriminalize assisted suicide. These bills are being reviewed by legislative committees and no votes have been scheduled yet, but the pro-euthanasia lobbyists are pushing hard. In New Mexico, two doctors have filed a court challenge against the state's laws prohibiting assisted suicides. If any of these are successful, they will join Oregon and Washington, where euthanasia has been legal for several years.

While it may appear that we don't have much say as to what happens in other states; what we can do is pray. Like abortion, euthanasia is affront to the dignity of all human life. From conception to the natural death, all life is a precious gift from God and has meaning. All our prayers are needed so that the elected officials will embrace a culture of life and work against these misguided bills. We also need to remain vigilant against any future attempt in our state to legalize assisted suicide. Please keep these states in your prayers, as well as, our own state and our nation during this election year.

### THE MYTHICAL WAR ON WOMEN

Rhode Island Representative Karen MacBeth (D-Cumberland) recently introduced legislation that would require ultrasound of the child before an abortion is performed. If the bill is passed, Rhode Island would join seven other states that have similar mandates.

Currently there are 18 states that are considering similar ultrasound bills. As expected, opponents of the bill are quick to call this another round in a mythical "war on women". Anyone who opposes abortion, contraception, and the HHS mandate are seen as aggressors in a fight against women's rights.

Let's get the facts straight. The reason that ultrasound laws are necessary is because many abortion providers do not give their patients all the information necessary to make the right decision. Women are often made to feel that an abortion is their only "choice." Secondly, calling this a war on women is nothing more than a distraction from the truth which is that abortion, contraception and the HHS mandates do nothing to empower women. Instead, they feed into a culture of death that objectifies women and deprives them of their Godgiven dignity while showing a callous disregard for human life and religious freedoms.
